## Facilities Report-

• Elk Grove Cemetery – Manager Lambdin reported on what he found on the Assessors website regarding the roadway at the Elk Grove cemetery. Trustee Lema will let Manager Lambdin know of a Title company for a title search on the Elk Grove cemetery to double check his findings.

• San Joaquin Cemetery – Manager Lambdin reported on the trash issue at the San Joaquin cemetery. **Staffing** – Job advertisement was posted this week according to Manager Lambdin.
