Trustees in attendance include Chair Peggy Forseth-Andrews, Dennis Buscher, Jessica Green and James Means. Staff: District Manager Jonathan Lambdin and District Secretary Debra Gale.

Public Comment: None.

<u>Consent Calendar:</u> Trustee Buscher made a motion to approve the August 15th and August 26th Special Board Meetings minutes plus August and September financial reports. Seconded by Trustee Means. The vote of approval was unanimous.

<u>Discussion and/or Possible Action Items:</u>

Facilities Report - Manager Lambdin reported on the following:

Staffing – Manager Lambdin reported what training has been completed for the month.

Equipment – Manager Lambdin reported that the 2013 truck tires have been replaced. He also reported picking up grave liners from Pettigrew and Sons for the District for the first time.

Pending Meetings – Chair Forseth-Andrews asked when the next Memorial Day planning meeting is. Manager Lambdin stated that it would be November 19th from 11 am to 1 pm. Golden Risk Management will be having a training meeting in Corning, CA which Manager Lambdin is trying to attend.

New Business -

Proposal of services for civil engineering- The Board reviewed this proposal before this meeting and discussed this proposal at the Business Meeting in July. Trustee Green made a motion to approve this proposal as written. Seconded by Trustee Buscher. The vote of approval was unanimous. Chair Forseth – Andrews and Manager Lambdin signed the proposal.
