The Board of Trustees of the Elk Grove – Cosumnes Cemetery District held a regular Board Meeting on Thursday, February 12<sup>th</sup> 2026 at 7:06 p.m. at the District office. Trustees in attendance include Chair James Means, Peggy Forseth-Andrews and Jessica Green. Staff: District Manager Jonathan Lambdin and Secretary Debra Gale. Absent Trustee Dennis Buscher.

**Public Comment:** None.

**Consent Calendar:** Trustee Forseth-Andrews made a motion to approve the January 8th Board Meeting and January 15<sup>th</sup> Emergency minutes as corrected. Second by Trustee Green. The vote of approval was unanimous. Trustee Forseth-Andrews made a motion to approve the financial reports for January. Second by Chair Means. The vote of approval was unanimous.

**Manager's Report:** A fire sprinkler pipe broke in the shop area of the Elk Grove Cemetery. This fire riser will need to be repaired and the whole fire system needs to be inspected. The fire system should be checked every five years. Everything should be out of the Kent Street warehouse by this Tuesday, February 17<sup>th</sup>. Dumpster will be moved and then a final walk through can be set up. A new employee will be starting this Wednesday, February 18<sup>th</sup>. The equipter is broken and needs to be welded. There was a false alarm at the new warehouse on Saturday. Chair Means and Manager Lambdin both checked out the building but cannot find any problems.
