Consent Calendar: Trustee Forseth-Andrews made a motion to approve the February 12th Board Meeting as written. Second by Trustee Means. The vote of approval is as follows: two ayes and one abstained. Trustee Buscher made a motion to approve the financial reports for February. Second by Chair Means. The vote of approval was unanimous.

Lastly, this week, Rita from Blomberg Accounting was in the office working on the 2024-2025 audit. Rita is hoping to have everything ready to be present by next month's Board meeting.
